MAKING HOLIDAY WISHES COME TRUE AT THE PARENT RESOURCE CENTER

It was a magical sight when Santa arrived on a Port Washington Fire Department fire truck at the Sands Point Preserve on December 10, 2020 making holiday wishes come true for some very young Port Washington residents. Santa brought with him gifts paid for by donations from the Port Washington community. Thanks to a generous grant from the Port Washington COVID-19 Community Response Fund (administered by the Community Chest), Rudolph the Red-Nosed Reindeer gave out gift cards for food and Port Pantry Supply Squad bags filled with personal care and paper necessities for all 45 families in the PRC Outreach program. The celebration also included a holiday-themed scavenger hunt through the woods and marked the end of the Fall 2020 outdoor Stepping Stones classes at the Sands Point Preserve. Helen C. says thank you: "We give thanks to our PRC for being so special with our children and for helping in their education. We value the class with other families and look to the Spring to join again. A thousand thanks to the Community Chest who has during supported us this pandemic time with necessities to meet our needs. It has been a big help. A thousand blessings." serve low-income families, are part of the parent-child program that provides early education enrichment for children ages 0-4. A typical class consists of gross and fine motor play, circle time which includes reading books, singing songs, and doing yoga, and an age-appropriate craft activity. During COVID, the PRC moved its Stepping Stones classes outside (to the Preserve) and has supported its Outreach families with donations of diapers, meals, coats, books and crafts for home use, gift cards and more.

Thanks in part to a generous grant from the Comunity Chest, the PRC's Outreach Program (comprised of Stepping Stones classes and scholarships to PRC classes) continues to provide early childhood education/enrichment to families who would not be able to afford these programs, helping prepare children for Kindergarten/Pre-K. These early childhood education experiences have an exponentially positive impact on children influencing their school experiences for years to come.

Says Christopher, an Outreach dad: "There is nothing more beautiful in life than to find people with grand hearts like the Community Chest. Through the PRC they make small instances into big moments. We thank you for all the help you have given to our family."

The four residents at Helen Keller's Destiny Home that stayed in Port Washington for Christmas celebrated the holidays a little differently this year due to the COVID-19 pandemic. Destiny Home is home to five residents who are deaf-blind and have intellectual disabilities.

On Christmas day, the staff ordered a holiday meal from Whole Foods, including champagne cups for special non-alcoholic drinks. The residents helped set up and clean up after the meal.

A generous donor provided funds to purchase gifts for the residents which were wrapped and placed under the tree for Christmas morning. While staying safe at home, the residents continue to train on work skills such as porter maintenance work and shredding. The dedicated staff continue to provide life skills support (e.g. personal and domestic maintenance, interpersonal communication and social skills and functional academics) while ensuring everyone's safety.

THE SAFE CENTER ACQUIRES CHILD ABUSE PREVENTION SERVICES

integrated the programs of Child Abuse Prevention Services (CAPS), a Roslyn-based grassroots nonprofit organization, into The Safe Center. For decades, CAPS programming, whose mission was the prevention of bullying and child abuse among school-aged children, has been presented in the Port Washington elementary

In July 2020, The Safe Center acquired and years of experience delivering CAPS' programs to Long Island elementary, middle, and high school students. These volunteers have been incorporated into the already robust volunteer education program at The Safe Center.

CAPS at the Safe Center expands The Safe Center's Community and Professional Education department's outreach across Long Island and leverages CAPS' 38 years of experience and relationships with schools and communities. Students and faculty will have increased access to educational workshops and programming, empowering them to recognize and respond to abuse. It also brings more than 75 experienced volunteer educators to join CAPS at The Safe Center. These highly trained volunteers have

at the Safe Center has held many virtual classroom workshops in the Port Washington School District. In October, CAPS at The Safe Center volunteers taught 3rd graders at Daly Elementary School about bullying and being an upstander (one who intervenes on behalf on someone being attacked or bullied) and discussed internet safety via its "Cybersmartz" workshops to all 5th grade classes. Plans for virtual workshops about internet safety, cyberbullying, and child abuse prevention at "Safety Rules Workshops" for students at programs and services can now be found on The Safe Center's website (tscli.org) under its new name "CAPS at The Safe Center."

The Safe Center welcomes Ilene Cooper, Bettina Finn, William Liu, and Karen Siris, former members of the CAPS Board to The Safe Center Board of Directors. Lorraine DiFiglia stated, "We extend our appreciation to The Community Chest of Port Washington for being a valued partner and champion for ending and preventing all forms of abuse within the Port Washington community."



SUMMER PROGRAM TO FIGHT HUNGER AND CLIMATE CHANGE

On Saturday, October 24, 2020, elected officials from New York State, Nassau County, the Town of North Hempstead as well as representatives from Plant A Row for the Hungry, Port Washington, Rewild of Long Island, the Mosaic Foundation for Autism, the Nicholas Center, Growing Love Community Garden, and the Science Museum of Long Island gathered at the Science Museum to recognize the efforts of those organizations to fight hunger and climate change. A virtual reception was hosted two weeks prior that presented the 2020 NYS Senate Commendation Award for "extraordinary dedication and lasting contributions to the community." This exciting recognition celebrated a bountiful spring, summer and fall of growing and harvesting. The collaborative effort included the participation of 17 high school students and their instructors in an ambitious project to grow organic vegetables for the food insecure families of Port Washington. The result was 5,000 pounds of organic produce delivered to their Port Washington neighbors and a great learning experience.

At the in-person ceremony, citations were presented by New York State Senator Anna Kaplan, Nassau County Legislator Delia DeRiggi-Whitton, and Town of North Hempstead Councilwomen Mariann Dalimonte and Veronica Lurvey. Engraved trowels and student awards were presented by program leaders Marvin Makofsky for Plant A Row, Raju Rajan for Rewild. Laurie Murdock for Mosaic Foundation and Hildur Palsdottir for the Science Museum.

Over 50 attendees, masked and practicing social distancing attended the outdoor ceremony. Says Senator Kaplan about the award, "The New York State Commendation Award is one of the highest honors that I as Senator can present, and it is reserved for a select few individuals each year whose exceptional work to support the community merits this level of recognition." Behind the masks, attendees were all smiles with so much to celebrate. The gardens used for this project demonstrate the large range of Port Washington organizations and included those at the Science Museum, the Historic Dodge House, the Helen Keller National Center, Growing Love Community Garden, Nicholas Center and the Port Washington Adult Activities Center. With his energy and enthusiasm never wavering, Marvin Makofsky, Plant-A-Row, Port Washington says that he has even larger plans for 2021 which include expanding the garden areas of these existing programs to increase production, a new greenhouse and a children's garden at the Science Museum.

SPECTRUM DESIGNS ACHIEVES MILESTONES

As if all that growth was not enough, Spectrum and the Nicholas Center demonstrated their COVID humanitarian

Every aspect of what we do requires volunteers to make it happen. Germinating, planting, watering, harvesting, distributing, educating, organizing and planning -- we have done all of this together as a team this year.

In 2020, Port Washington based Spectrum Designs Foundation grew its three social enterprise businesses -- Spectrum Designs, Spectrum Bakes and Spectrum Suds, expanded to a second location in Westchester, New York, and maintained employment for seven Port Washington residents with Autism.

Milestones for Spectrum Designs and its partner agency—The Nicholas Center include graduating 11 individuals from their first-ever Screen Print Certification Course and fulfilling its largest Spectrum Bakes order to date – 10,000 Better Bars – baked, sealed and shipped in 1 week! Development Manager, LeeAnne Vetrone, states, "despite challenges from the pandemic, we've expanded our neurodiverse workforce." She adds,

"chops" with several initiatives during 2020: free laundry service to first responders during the height of the pandemic; acquiring and distributing 150,000 units of vital PPE (masks, gloves etc.) for first responders, businesses, and community members; monthly deliveries of fruit donations (from R Best Produce) to Port Washington food pantries; maintaining the Port Pantry Supply Squad distribution and delivery system; rolling, labeling and shipping 38,000 NY Tough Poster orders; and laundering and steam pressing 2,000 hand-made face masks for the "Port Washington Mask Brigade" project though the Community Chest.
